DISCUSSION

On September 20, 2021, the District received a letter of resignation from the Board from Director Elena David, citing her current health situation. At the October 12, 2021, Regular Meeting, the Board directed staff to initiate the process to accepts applications to appoint a successor to serve out the remainder of Director David's term.

Following the meeting, staff published several advertisements and public notices, sent out numerous letters to potential candidates and posted to social media regarding the vacancy. Two applications were received; however, one was received after the published deadline, therefore, has been disqualified. Confirmation has been made with the election's office of residency and voter registration status.

If the Board chooses to appoint tonight, the appointment becomes effective following the completion of today's meeting. At that time, the applicant/appointee assumes all responsibilities, however, will need to be sworn in at the next regular meeting.

If the Board declines to appoint a successor or call for an election by November 19, 2021, then the County Board of Supervisors will appoint a person to fill the vacancy "within 90 days of the date the District Board is notified of the vacancy or the effective date of the vacancy, whichever is later, or the board of supervisors may order the district to call an election to fill the vacancy." (Government Code §1780(f)(1))

Finally, if both the District Board and the Board of Supervisors decline to act within the above-referenced time frames, then the district board is required to call an election on the next established election date to fill the vacancy. (Government Code §1780(q)(1)).

RECOMMENDATION:

Staff is recommending that each board member choose two or three questions from the list and the procedure for interviews will be as follows:

- (a) Standardized questions from the list for Candidate(s) from the Board
- (b) Questions for Candidate(s) from the public
- (c) Individual follow up questions for Candidate(s) from the Board
- (d) Candidate(s) closing comments
- (e) Public Input
- (f) Board discussion
- (g) Consider Motion for appointment to fill the vacancy for Division 4

Question 1. Do you have prior experience serving on a governing board, specifically a governmental organization? Please list such prior experience.

No. I have however been appointed and served on scientific advisory boards and panels for government agencies. I am a PhD geneticist specializing in trout and salmon population genetics and culture. For California Department of Fish and Wildlife I served on panels reviewing the hatcheries in the Klamath and Trinity Rivers and developing guidelines for a Tuolumne River salmon hatchery. For CalFed I reviewed steelhead supplementation in Battle Creek and a monitoring and evaluation plan for Coleman National Fish Hatchery.

For six years I served on the Independent Scientific Advisory Board (ISAB) providing guidance to the Northwest Power and Conservation Council (NPCC), NOAA-Fisheries, and the Columbia Intertribal Fish Commission on the Columbia River Basin Fish and Wildlife program (FWP), funded by Bonneville Power Authority and implemented by the NPCC. For five years I was the ISAB chair, steering the work of eleven scientists from across the United States and Canada. For six years I served on the Independent Scientific Review Panel (ISRP) for the NPCC. The panel provides technical review of FWP projects for the NPCC. Direct FWP projects have a budget of approximately 250 million dollars annually.

The ISAB and ISRP were established by Congress. Both board and panel operated with consensus. Our reporting to the regional governments presented the elements of an issue or project that all members agreed on. As chair I regularly reported to the NPCC at their monthly meeting. The reports I helped produce are available at the NPCC website.

Question 3. Why do you want to serve as a Director of the AFPD Board?

A neighbor brought the opening to my attention, suggested I would be a good choice, and urged me to offer my services.

I have no specific knowledge of fire departments and would not bring an existing agenda to service on the AFPD Board.

I have lived in Arcata since 1983. Most of this time I was busy enough with my duties at HSU and my service to the conservation of our region salmon and steelhead resources that I did not purse volunteer service in our local community.

Now that I am retired from both HSU and my service to the ISAB and ISRP I would be able to commit to serving in our local community. Serving on the AFPD Board would provide an opportunity to give back to the community where I have lived for nearly 4 decades.

4. What specific expertise would you bring to the Board of Directors?

No technical expertise, but several years of serving and leading collegial advisory teams. I am confident that I am able to learn the operations of the Fire District and could make responsible decisions on behalf of the citizens of Division 4.

5. What do you see as a strength of the Fire District?

I don't have sufficient knowledge of the AFD to compare it to other local or regional fire or other special districts to make a cogent statement of strengths.

6. Please explain any weaknesses or areas of improvement that may be needed for the Fire District.

As stated above, I don't have sufficient knowledge or understanding of the Fire District to make any suggestions for improvement of technical matters. I suspect that District efforts at transparency and public relations could be improved, given community resistence to recent ballot initiatives for special taxes for the Fire District.

I hereby certify I am a resident, and qualified voter, of Division 4 of the Arcata Fire District and wish to be considered for appointment to fill a vacancy on the Board of Directors. The term of the vacant seat expires in November 2022. The appointed candidate may seek re-election at that time.
